A motion was made, seconded and passed to accept the Treasurer's Report as read.

Regional Membership Director - Jeff Port

Jeff passed out packets to Governors containing the 51% sheet, membership receipts and results for 1994. The East Region renewed between 1300 and 1400 members which is down 219 members from last year. The club with the largest percentage of new members is Pocono Mountain Corvette Club. They did 56% new members bringing their total membership to 95 renewals and 24 new members. A gift certificate from Auto Accessories of America was given as an incentive reward to Pocono Mountain Corvette Club.

Jay Gittleman made mention that national has mailed all renewal packets containing new NCCC membership cards.

Jeff noted that for 1995 the 51% sheets will follow the normal deadline of November 30 and **will not be extended under any circumstance.** Governors must return all material to Jeff by November 30, 1995. If there are any problems or corrections, Jeff will handle those matters at the December regional meeting.

Regional Competition Director - Bambi Lyberger

Bambi distributed the 1994 final point standings to the Governors. Bambi also mentioned that there is still 1994 trophy funds not collected.

Regional awards for 1994 were discussed among the Governors in attendance. It was agreed that the award shirts for '94 will be turquoise. Governors, please see that Bambi receives the proper shirt sizes so that she can purchase the awards and distribute them at the next regional meeting. The first place awards will be jackets in a solid color similar to those given last year. It was also decided that the overall first place award winners will receive a satin jacket in cranberry, white and teal. These jackets will also have a car on the back of the jacket in the style and color chosen by the person awarded the jacket.

Bambi also printed and distributed the calendar for 1995. There were a few events added as well as some rescheduling of events. Please note your calendars accordingly. Bambi also reviewed the deadlines for 1995 on the material in Jeff's packet to the Governors and requested that everyone adhere to the deadlines to help make her job easier.

Bambi made mention of her new address and distributed labels to the Governors to use when mailing results.

A discussion was held on competition problems associated with judging of events, competing, points as well as the amount of events held. Any proposals on how to change these situations are to be mailed to Bambi for review on making 1996 rule changes and/or upgrades. It was decided however that for 1995, there will be an award presented to workers of events. These workers will be removed from other competition point standings and stand on their own merit. They will also be awarded first, second and third in both the men and women listings.

Regional Executive - Tina Gittleman

A discussion was held concerning the regional newsletter. The Governors in attendance decided to allow the newsletter to be published another quarter with further discussion after distribution and feedback from corresponding clubs. Any articles for this publication is due February 11, 1995.

One of the regional guests, Mr. Bill Johns, discussed a computer system set-up on internet for members personal computers. Start up fees are \$75.00 for any member interested. Members may contact Mr. Johns via G-Burg Vettes in Maryland.

Lonnie Jackson of Lancaster County mentioned a large sanctioned show to be held at the Farm Show building in Harrisburg, February 17, 18, and 19, 1995. Registration forms were distributed.

A question was raised on whether one club alone can host a Corvette Dream and Drive. No, the entire region is invited to host the regional event.

Discussion concerning the scholarship fund was tabled to the next meeting.

There being no further business, the meeting was adjourned.

Secretary's Report - Bambi Lyberger

Bambi recommended that the East Region accept the resignation of Nick D'Archangelo from the office of Secretary/Treasurer. The following two members have volunteered to serve the remainder of 1995:

A motion was made, seconded and passed to accept Nick's resignation and to elect Bill and Karen to the Secretary and Treasurer positions, respectively.

A motion was made, seconded and passed to accept the Minutes from the January 21, 1995 East Region Governors Meeting as printed and distributed to the governors.

Treasurer's Report - Bambi Lyberger

There was no Treasurer's Report since Nick was not at the meeting and did not send a report.

Regional Membership Director's Report - Bambi Lyberger

Jeff Port was not at the meeting due to a work commitment. Bambi reported that NCCC had over 10,000 members renew, which has never occurred before. Bambi reported that there will be a tour of the Corvette Assembly Plant and the National Corvette Museum on Friday, September 8, 1995 as part of the September National Governors Meeting in Louisville. The tour will be limited to 100 people (2 buses) and will cost \$15.00 which includes a box lunch and entrance to the Museum. As of February 3, 1995, the East Region had 1,430 members with Lancaster County Corvette Club being the largest club in the Region with 259 members. It was reported that new members are not receiving membership materials from the National Distribution Center in a timely manner. Jeff will check into this. 1995 NCCC Renewal Packets were sent out in the middle of January 1995.

Scott Cox of Hampton Roads Corvette Club has a problem with NCCC's "dependant member" membership category. He has a 16 year old that wants to join HRCC and NCCC but the By-Laws of his club will not permit 16 year olds to join. Does the club have to change its By-Laws to conform to NCCC's dependant member category or can it just refuse to allow a 16 year old to join?

Regional Competition Director's Report - Bambi Lyberger

Bambi distributed a copy of the latest 1995 East Region Competition Calendar

Changes to 1995 East Region Competition Calendar:

Bambi reminded the governors of the competition paperwork deadlines. Be sure to get the paperwork in on time and provide the correct number of copies. Bambi can be reached every evening after 7:00 PM if you need to talk to her.

The following proposal was discussed:

Autocross, Concours and Rallye Events:

You must enter 5 or more events to be eligible for an award.

Overall Standings:

You must enter 15 or more events to be eligible for an award.

Worker Awards:

You must work 5 or more events to be eligible for an award.

A motion was made, seconded and passed to accept the above proposal as a basis for granting East Region Competition Awards

Bambi reported that we received \$176.00 from National for 1994 Competition Awards. Bambi reminded the governors that checks for the 1995 East Region Trophy Fund should include \$25 for each NCCC worker.

The current NCCC Rulebook is in the fourth year of a five year rulebook (1992-96). The National Competition Committee is going to recommend that we change this to a four year rulebook (1992-95) and then adopt another four year rulebook (1996-99) that would begin in 1996. This proposal makes sense and would match up with two consecutive two-year terms of the NCCC Vice President of Competition.

There was a discussion of NCCC High Speed Events. Additional safety equipment is highly suggested for all classes. Some feel that there may be a problem if we require too much safety equipment, we will lose a lot of Group I competitors that do not want to modify their cars. It was also suggested that completion of seven low speed events does not necessarily qualify or prepare a competitor for a "High Speed Certification". Maybe we should consider mandatory drivers schools or annual certifications for high speed events.

Bambi noted that the new NCCC Rulebook that is being prepared will include a "People's Choice Concours" that will allow the host club to set up the rules and classes. This proposal is a sort of an expansion of the "display" or "exhibition" class that we have in the present rulebook to allow NCCC members to earn points at a car show without having their car judged using NCCC Concours class standards.

Bambi reminded the governors to use the new insurance waivers from the 1995 K & K Insurance Package for all sanctioned and non-sanctioned NCCC events this year. The 1995 revised "general" waiver and the 1995 new "rallye" waiver are the only "legal" waivers for NCCC events. If you need more copies of the waivers, send in the post card from your insurance package.

Congratulations to East Region members Scott Cox who finished in 6th place and Bambi Lyberger who finished in 7th place in the Nation in 1994!!

Bambi handed out the "red" 1994 Regional Award Patches and the "teal" 1994 Regional Clothing Awards. Bambi expected to get the National Award Patches at the May National Governors Meeting.

Regional Executive's Report - Tina Gittleman

Tina reported that the Cadillac Club will do the Cadillac Dream and Drive in 1995. We do not have any information about the dates and places for the Corvette Dream and Drive at this time. As soon as Tina gets any information, she will inform the governors. Jay Gittleman noted that the NCCC Insurance Policy provided by K & K Insurance has been extended to December 15, 1995, the last day of the competition season.

Under Old Business, the Regional Newsletter was discussed. Everyone felt that the second newsletter was an improvement over the first one. Jeff Port did the editorial work and Jay Gittleman mailed it out. It was felt that more advertising money was needed to make the newsletter self-sustaining. The Spring issue cost about \$700.00 to produce and generated \$300.00 in advertising. The newsletter is sent to all primary members in the East Region and to all advertisers. It was decided that the region will continue with the newsletter for a year, producing Spring, Summer, Fall and Winter issues.

A motion was made, seconded and passed to reimburse the Justus Volunteer Fire Company \$85.00 for the use of the Fire Company Postal Permit that we have already used twice to mail out the Regional Newsletter.

The next newsletter will be assembled in June and mailed out in July. All East Region members are encouraged to sell as much advertising as possible to help keep down the cost of the newsletter. Jeff Port also needs Corvette related articles for publication in the Regional Newsletter.


The possibility of the East Region hosting another NCCC National Convention was discussed. Jay noted that Split Rock Lodge and Mount Airy Lodge are in financial trouble. He is concerned that we may not be able to find any place in the Poconos that is big enough to host a National Convention. Jay asked the governors to come up with a convention bid between now and the next Regional Meeting. It can be in the Poconos, in Maryland, in Virginia or any other location in the East Region. He noted that it takes several years to plan, bid and pull off a successful convention. Things to consider include high speed, low speed and record drag events. Right now we should be looking at 1998, 1999 or 2000.

A discussion took place concerning the East Region Trophy Fund. We are not collecting enough money to pay for the Regional Awards each year. Suggestions included charging more per entrant (\$50, \$.75, or \$1.00). A motion was made and then withdrawn to charge \$15.00 per NCCC sanction instead of the entrant fee. Proposals for the 1996 East Region Trophy Fund will be discussed at future regional meetings and then a decision will be made later this year that will be used in 1996.

A motion was made, seconded and passed to transfer \$2,000.00 from the Region's Ginnie May Investment Account to the checking account to cover regional expenses.

The meeting was adjourned at 3:00 PM. The next East Region Governors Meeting will be held at the Bonanza Steak House in Harrisburg, Pennsylvania at 11:00 AM on Saturday, June 17, 1995.

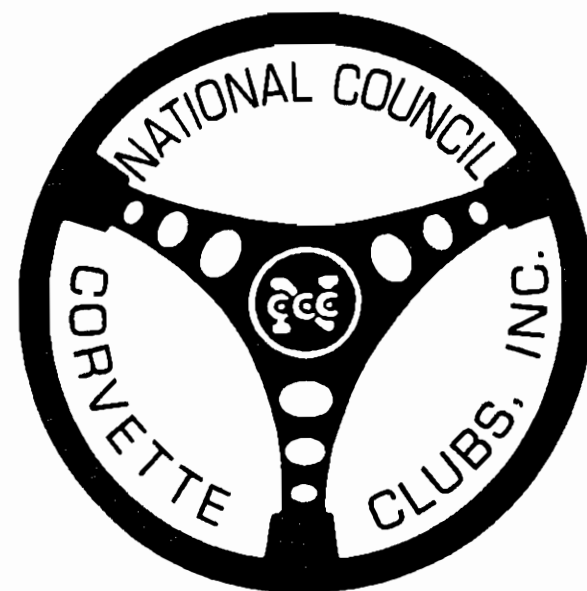
