Secretary's Report - Bill Trethaway

A motion was made, seconded and passed to accept the Minutes from the December 2, 1995 East Region Governors Meeting as printed and distributed to the governors.

<u>Treasurer's Report</u> - Bill Trethaway

East Region Treasurer Karen Sellers could not attend the meeting due to severe weather conditions in the State College Area. A copy of the Treasurer's Report that she prepared in the following three parts is included with these minutes:

- 1. Year-To-Date Cash Flow Report for the period from January 1, 1995 to December 31, 1995.
- 2. First Period Cash Flow Report for the period from December 1, 1995 to January 20, 1996.
- 3. Ginnie Mae Account Statement as of December 31, 1995.

A motion was made, seconded and passed to review the January Treasurer's Report at the March East Region Governors Meeting

Regional Membership Director's Report - Bambi Lyberger

East Region Membership Director Jeff Port could not make the meeting due to severe weather conditions in the State College Area. Bambi welcomed Greg Smith, Governor of Beachcombers Corvette Club, to the East Region. Beachcombers Corvette Club from Virginia Beach, Virginia transferred from the Carolina Region to the East Region because of the recent NCCC Regional Boundary changes. The East Region now includes the entire State of Virginia. Our next goal is to have the East Region Boundary include the entire State of Pennsylvania.

Bambi reported that Jeff Port still had to resolve some minor problems related to the East Region Clubs 1996 NCCC Membership Renewals. Jeff expected to work with the individual clubs to resolve these problems as soon as possible

A discussion was held concerning notification to new members of NCCC A member who joins NCCC in late August of one year could wait until February of the next year to hear from our National Membership Committee. During this period of time, the new member does not have an NCCC Membership Card or an NCCC Rulebook. Lonnie Jackson of the Lancaster County Corvette Club said that his club sends new members a "welcome letter" as soon as they join the club. This is good but the new member has still not been acknowledged on the regional or national level. It was suggested that Jeff Port bring this problem to the attention of the National Membership Committee at their next meeting in February 1996. A possible solution would be a form letter or a post card from both the Regional Competition Director and the Vice President of Membership welcoming this new member to NCCC. A temporary membership card showing the new member's NCCC Number would also be desirable. It was the general feeling that the long period of time that a new member has to wait to receive regional and/or national membership notification makes it more difficult to get this member to renew his NCCC Membership It was also suggested that now may be the time to hire a paid National Membership Director who can spend full time handling NCCC Membership matters. It was a general consensus of the East Region Governors that NCCC new member notification is a very serious problem that should be addressed by the NCCC National Membership Committee as soon as possible

Regional Competition Director's Report - Bambi Lyberger

Bambi Lyberger distributed a copy of the "1996 Competition and Non-Competition Guidelines" and a copy of the "1996 Paperwork Deadlines" to all governors at the meeting. Bambi included seven copies of the sanction request form, seven copies of the event flyer form and seven copies of the event results form to be used in 1996. Also included were copies of the various concours forms as well as tech sheets for speed events, rallyes and funkhanas. Bambi said that she would mail a similar package of guidelines, deadlines and forms to the governors who were not in attendance. Bambi stated that she plans to strictly enforce <u>all</u> of the competition guidelines and paperwork deadlines!!

Bambi asked if there were any changes to the 1996 East Region Competition Calendar included with the December 1995 East Region Minutes The only change was to move E-063 BACC Concours from Sunday, March 17, 1996 to Sunday, April 14, 1996.

Bambi noted that the 1995 East Region Competition Trophy and Clothing Awards will be presented at the March East Region Governors Meeting. Scott Cox produced the "Mileage Reference Table" to compute distances between East Region Clubs using an "Automap Program" on his computer.

Bambi presented "highlights" of the new NCCC Competition Rulebook which will be in use in 1996, 1997, 1998 and 1999. There is a new group for speed events - "Group I Street" - for Corvettes with no modifications including original size OEM tires. Autocrosses and Matching Time Trials are now separate events that cannot "share" run times. High Speed Certification now involves seven speed events held on at least three weekends. Recognized Driving Schools (Car Guys, SCCA, etc.) can be used in place of the seven speed events. There is a new tech sheet for rallyes and a new tech sheet for funkhanas. The rallye minimum mileage is now 10 miles per rallye and there is a 4 mile notification restriction between clues The new type of concours is a "People's Choice Concours' where all entrants receive 3 points Please remember to specify whether the concours is a "Regular Concours" or a "People's Choice Concours" on the event flyer. A "Regular Concours" and a "People's Choice Concours" cannot be held on the same day unless they are separate sanctions at the same location or the events are 150 miles apart The Concours Custom Class has been split into: 1953-1982 and 1984-1996. Concours class changes end one hour before close of registration Please consult your new rulebook for concours points which have changed from last year. Information about "Restroom Facilities" and "Refreshments" (Available/Not Available) should be included on each flyer. A copy of the new NCCC Competition Rulebook must be available at all sanctioned events. The maximum number of events that can be held in the East Region on any given day is seven

On the regional level, Bambi reminded the governors that the East Region Trophy Fund increased from 25 cents to 50 cents for each NCCC entrant and each NCCC worker at East Region sanctioned events effective January 1, 1996. Bambi also noted that the Regional Autocross/Concours/Rallye Points Calculation Method would include travel points beginning in 1996.

Regional Executive's Report - Bill Trethaway

East Region Executive Tina Gittleman could not attend the meeting due to the severe weather conditions in the Olyphant Area.

Bill Trethaway led a discussion of the auto insurance program for NCCC Members presented by Rally Insurance Company at the November National Governors Meeting It seems that Rally Insurance Company is mainly interested in insuring antique, classic or collector Corvettes that are not driven on a regular basis Rally Insurance Company will give you a quote for auto insurance on a Corvette that is driven on a regular basis if you call them on their 800 number and remind them that they offered auto insurance for "Daily Driver Corvettes" as part of their presentation to NCCC in November.

The Spring 1996 issue of the "East Region Newsletter" will be the final issue because it is not self supporting after one year and also because Jeff Port has resigned as Editor due to work commitments.

After lunch, a discussion took place concerning the Sheraton Working Lunch Buffet. Most agreed that the buffet had good food at a reasonable cost and that the meeting and lunch setup fit well with the East Region Governors Meeting Schedule. Dave Walter checked with the Park Side Cafe in Harrisburg as a possible site of East Region Governors Meetings but found out that their kitchen does not open until 4:00 PM on Saturdays. Gus Bartoli reported that the Hampton Inn on Union Deposit Road in Harrisburg did not have space available for meetings on the 1996 East Region Governors Meeting Dates.

The deal we have worked out with the Sheraton Inn involves getting a free meeting room in exchange for purchasing a minimum of twenty lunch buffet meals at approximately \$11 00 each including tax and gratuity

A motion was made, seconded and passed to hold the five remaining 1996 East Region Governors Meetings at the Sheraton Inn with the same arrangements as the December 1995 and January 1996 Meetings The East Region Treasurer will collect \$10.00 from each person that eats a meal with the East Region paying the balance.

Since no one has volunteered to serve as East Region Secretary for 1996, Bambi Lyberger has agreed to perform the duties of Secretary until a candidate can be found. Bill Trethaway asked all of the governors to recommend someone who will serve as Secretary in 1996 since Bambi's duties as East Region Competition Director will take a great deal of time to perform.

Bill stressed the importance of attendance at East Region Governors meetings. Each governor should try to attend as many meetings as possible. These meetings are important for conducting regional business and serve as a forum for the regional officers to report to the regional governors what is going on at the meetings that they attend at the national level. If a governor is not able to attend a particular East Region Governors Meeting, it is recommended that a proxy governor be selected to represent that club at that meeting

The meeting was adjourned at 2:15 PM. The next East Region Governors Meeting will be held at the Sheraton Inn in Harrisburg, Pennsylvania at 11:00 AM on Saturday, March 30, 1996.

Secretary's Report - Bambi Lyberger

A motion was made, seconded and passed to accept the Minutes from the January 30,1995 East Region Governors Meeting as printed and distributed to the governors

Bambi also thanked Bill Trethaway for typing the minutes from the January meeting.

Treasurer's Report - Karen Sellers

Karen gave the current balance in the account of \$1,724.38. Due to a computer error, she did not bring copies to the meeting They will be enclosed in the minutes.

Regional Membership Director's Report - Jeff Port

Jeff made copies of the Master Book for each club He also has membership forms available He found that most of the problems with members not receiving their renewal packets was due to incorrect addresses.

There are two new clubs in the East Region and were represented at the Meeting They are:

Aquia Creek Corvette Club, Stafford, Virginia Capital Area Corvette Club, Olney, Maryland

The new NCCC Charity is the National Kidney Foundation Those in attendance viewed a video tape about the organization The tape contained video and discussion with the 1994 US Transplant Games The tape was approximately 15 minutes long Tina Gittleman handed out the local National Kidney Foundation Organization addresses for East Region locations

Regional Competition Director's Report - Bambi Lyberger

At the January meeting, Bambi presented Lonnie Jackson with a 1995 Outstanding East Region Governor certificate Roland Driver was presented with the Outstanding East Region Governor certificate at the March Meeting. These certificates were presented for correct and timely paperwork, events organization, and governor's participation and administration of the NCCC program.

Bambi handed out the 1996 Events Calendar, effective as of March 17, 1996 There were several additions to the calendar:

Bambi stated the addition of the 2 new clubs requires a change in the written postage amounts listed in the RCD guidelines. The NEW rates are: Either check for \$14.40 made payable to Bambi Lyberger, or 45 stamps A check is the preferred method of payment due to administrative logistics

A reminder: If you send an inadequate number of copies to her (flyers, results, etc.) your club will be assessed \$1.00 per copied page. Remember, you need to send in 3 copies of the sanction request, 50 copies of the flyers and 3 copies of the results.

A reminder: There are two types of waivers; one for rallyes and economy runs and the standard one which is used for all other types of events. Be sure to use the correct waiver. This is an insurance requirement that must be met!

Bambi went over the National Competition Committee Clarifications from the February 23, 1996 Meeting. These are included in the back of the National Minutes sent to each Governor.

Several items were handed out. They are as follows:

The 1995 Apparel Awards were not at the meeting They are being worked on and will be at the June Meeting. The 1995 Regional Patches for the individual events were handed out. There were some errors, which are being corrected. The 1995 Overall East Region patches will be at the June Meeting

Lancaster County Corvette Club was awarded the 1995 1st Place Club Bowl

Two leadership awards were presented Jeff Port was presented the RMD Award for the years of 1993-1995 and Bill Trethaway was presented the Regional Secretary Award for 1995

K&K Optional Coverage Forms for autocross were sent out in a 2nd mailing due to incorrect copies in first mailing

A question was raised at the January meeting in regards to having a People's Choice and Regular Concours at the same site Ruling is that a People's Choice can be held at the same site, or held at the same time as a Regular Concours, but each event must have a separate sanction

Regional Executive Report - Tina Gittleman

Jay Gittleman resigned from the Convention Steering Committee

NCCC has been fined a penalty by the IRS It is a \$17,000 fee for not filing or late filing. NCCC has paid the penalty, but is pursuing a course of action to get the money back

There will be **NO** Corvette Dream and Drive in 1996 However, there will be a Cadillac Dream and Drive in selected cities Money awarded is \$1, 250.00 for one day and \$3,000 00 for an entire weekend.

There were two NCCC Standing Rules changes in 1995. A suggestion was made that the National Distribution Center send out a coupon for obtaining copies of these for insertion in to the rule book

A idea was brought up about giving the Governors the option between 4 or 5 charities to choose from and let the governors vote on it

A motion was made at the February National Governors Meeting to allow "warm body" vote for National Meeting Sites This was tabled until the next National Governors Meeting A regional vote was taken and the region decided unanimously to vote against this proposal.

There will be NO Bowling Green Corvette Plant Tours after April 4, 1996 due to the new 1997 Corvette.

A question was asked about clubs having to file tax forms. Forms need to be filed for any incorporated body or non profit organization. You MUSI check your local state laws It is recommended you secure the services of a CPA or Tax lawyer for the correct and proper action

Old Business

The Newsletter should be out in the next couple of week Jeff is working on it and will get it to the printer as soon as possible This will be the final issue of the newsletter due to lack of advertising support and general club interest

Jeff Port announced that he was stepping down as Regional Membership Director and George Fanucci volunteered to take the position A unanimous vote was recorded electing George as the new RMD for the remainder of 1996. (1997 Region Officer elections will be held in October.)

New Business

A motion was made for the region to purchase a new tape recorder, not to exceed \$75 00. The one donated by Art Wilner is not recording properly A vote was taken and passed

Congratulations were given to Lancaster County Corvette Club for finishing as the "Top Concours Club in the Nation". Also, congratulations were extended to Scott Cox and Bambi Lyberger for both finishing 5th in the 1995 National Points Championship

A suggestion was made the NCCC should recognize the top club in the individual events of Concours, Low Speed, Rallye, etc This will be taken to the next National Meeting and brought up at the RCD round table discussion.

Clubs wishing to get a copy of Jerry Britner's monthly letter should send a self addressed stamped envelope to Karen Sellers and she will send a copy to you

George Fanucci discussed the Memorial Day Weekend in Scranton and at Pocono International Raceway There are two low speed autocrosses on Saturday and three on Sunday On Monday, there will be a driving school and 2 high speed events at PIR You can only do the high speeds or the driving school, not both

A motion was made that the Region purchase 10 new rule book covers, to be picked up and brought back to the region, saving postage. They are \$8.00 and will be sold for \$8 00 to the first 10 buyers Contact **Tina**.

Bambi has high speed certification cards. Contact her if you need one

The meeting was adjourned at 1:45 PM.

A motion was made, seconded and passed to accept the Treasurer's Report as presented

Membership Report - George Fanucci

George announced he wants all club renewals by November 15 This is his first time handling renewals and wants plenty of time to get them processed Also, this gives him chance to get corrections made in time to meet his deadline to National

NCCC Membership Renewals Packages have been mailed to each club governor by Nancy Sable

The East Region has 1,748 active members to date and 30 clubs

Competition Report - Bambi Lyberger

Bambi distributed the "East Region Competition Report" (October 4, 1996) She reviewed the standings (overall points, clubs, Autocross, Concours, Rallye and Workers), the Trophy Fund Data, and the 1996 East Region Competition Calendar

Two sanctions have been added to the Competition Calendar They are as follows:

E-104	CVCC Funkhana	1 2-8- 96
E-105	CVCC Funkhana	12-8-96

She noted several errors on paperwork. They are:

- 1. Flyers must have each sanction number, chairman name and phone number and event type
- 2 Results scores and classes must be filled in on concours results

Bambi noted some areas in the concours events that need to be watched carefully

- 1 Clubs need to classify cars to make sure they are in the correct classes
- 2 Judging follow the order as in the rule book: Exterior, Interior, Engine
- 3. Judges under no circumstances are allowed to touch cars or get down on their hands and knees to judge cars.

A question has been raised as to the Worker Award program. We started the worker award program back in '95. It gives people the chance to win a regional award without having to participate in an event All NCCC members should be allowed to work at other club events However, not all workers may be needed at certain types of events. It is recommended that you call the event chairman in advance to see if they will need help.

Clubs putting on funkhanas need to make sure that they use the four classes listed in the rulebook and give a minimum of two runs.

Bambi thanked Jay for sitting in for her at the National Competition Committee Meeting in Louisville in September Tire categories and lots of clarifications from the Southwest Region were the bulk of that meeting.

Regional Executive Report - Tina Gittleman

Tina noted that there were minor bylaws changes on the ballot this year One was for convention profit instead of 60/40 split change to 50/50 split There was one bylaw that many feel should be voted against It was eliminating the proxy vote for the selection of the National Meeting site

There were 710 people registered for 1996 NCCC National Convention in Orlando, Florida They made a \$14,000 profit.

The 1997 NCCC National Convention is being held in Cleveland, Ohio on July 12-18, 1997 The high speed event is being held at Nelson Ledges The host hotel is a Holiday Inn. Room rates are \$79 00 plus tax and room surcharge

Tina handled out to all the governors the 1998 NCCC Convention Bid packet for St Louis. Colorado Springs was suppose to be bidding for '98 also but withdrew at the last moment

Old Business

Nominations for Regional Officers were reopened, closed and voted upon. The 1997 East Region Officers are as follows:

Regional Secretary - Bambi Lyberger Regional Treasurer - Karen Sellers Regional Membership Director -George Fanucci Regional Competition Director - Bambi Lyberger Regional Executive - Bill Trethaway

Some governors had already received their voting ballots for National Those in attendance reviewed the officer ballots and bylaws. Several recommendations were made

Bambi mentioned that the checks sent in by advertisers for the East Region Newsletter have never been returned Karen Sellers said she would make sure this got returned immediately

Proxy forms were enclosed in each clubs renewal package. A recommendation was made to have 6 forms filled out in case something happens to one of the officers so the East Region clubs will be represented at each National Governors Meeting

New Business

George Gallant suggested that the region think about having a Spectacular or Social event in the region. Governors were asked to take this back to their clubs for discussions and bring feedback to the December Governors Meeting

Bill Trethaway is checking into having our Regional Meetings in 1997 at the Sheraton Inn again.

The 1997 East Region Competition Calendar was prepared

The meeting adjourned at 2:20 PM.

Regional Competition Director's Report - Bambi Lyberger

Bambi presented Bill Irethaway and Scott Cox (not in) attendance with Certificates of Appreciation

Bambi also handed out the East Region Competition Report and reviewed the point standings to date She also asked that clubs still owing money for the 96 trophy fund to please get their payments in

She noted that the last 2 events in the region this year on being held on Sunday. December 8 and are 2 funkhanas hosted by Cumberland Valley Corvette Club

Bambi handed out the '97 East Region Competition Calendar There were 2 additions They are as follows:

E-072	YCCC Concours	February 1, 1997
E-073	LCCC Concours	October 12. 1997

She reviewed the highlights of the National Competition Committee Meeting held on November 8 1996 in Louisville, Kentucky They are as follows:

- 1) Two runs per event; no exceptions Cannot designate which run is for points
- 2) Minor waiver must be signed for all moving competition events(i e autocross, drags, funkhana, rallye)
- 3) No minors are allowed to participate in funkhanas This is a speed event
- 4) For Cruise-Ins. waiver must be signed
- 5) 15 days notice needed for non sanction events
- 6) 1997 K&K Insurance policy will cost \$48 745 If paid all at once. get a 10% discount
- 7) 5 claims in 1996 Insurance is only 3rd party insurance Does not cover you or your car
- 8) 1997 Vette New class for SPEED EVENTS IHS, IH, IIH, IIIH, RP (competition has reserved the right to review when further information becomes available for possible reclassification) New class for CONCOURS. F class
- 9) Event Results
 - a) Must be legible and complete
 - b) NCCC numbers must be exact No such numbers as pending or applied for
 - c) Scores and classes must be listed
 - d) Men need to be listed separate from ladies in autocross results
 - e) Don't list people twice if they are a worker and entrant List only once
 - f) Club names must be spelled out in club summary section on the back of the result form

Bambi noted that there have been several cases of unsportsmanlike conduct in the region. Anyone displaying this type of conduct at an event will be asked to leave the event immediately. No warning will be given.

Bambi handed out the '97 Deadlines This paper list the date of the event, the sanction request, the flyer and the results needed to be postmarked by in order to have the event on that day **Postmark dates will be checked**

She also handed out the 1997 Competition and Non Competition Guidelines noting the following:

- 1) 3 copies of the sanction request must be postmarked 70 days prior to the event
- 50 copies of the flyer must be postmarked 50 days prior to the event along with a check for \$14 40 made payable to Bambi Lyberger or 45 stamps
- 3) 3 copies of the results, 1 copy of the signed waiver (typed or computer generated preferred)
 - a) No such number as pending or applied for Will not look up numbers
 - b) If printed, must be legible If not, will be returned to be redone
 - c) Anyone not signing waiver does not get points
 - d) MAL's are not listed in club summary section on back of the result form
 - e) Club names must be spelled out in club summary section
 - f) Make sure that when totaling club points that entrants and worker points are included
 - g) Check for travel points (see chart handed out)
 - h) Entrants living more than 50 miles from home club get travel mileage calculated from home town

Bambi noted that George Fanucci will be handing out in January and August a list of all the NCCC members and NCCC #'s to each club governor to help with doing results

She also handed out seven copies of the following

- 1) Sanction Request form
- 2) Flyer form
- 3) Result form

Bambi noted that the 1996 East Region Apparel Awards will be yellow She will be contacting club governors for their club members sizes

Regional Executive Report - Bill Irethaway for Tina Gittleman

Bill handed out a list of the 1997 NCCC National Officers, the 1997 NCCC and Regional Meeting Dates. and 1997 East Region Officers He also went over the results of the Bylaws and Standing Rule vote

He also noted that there were some problems with the '97 proxy forms He will be sending out a letter to all governors and will note any corrections that need to be made
