The meeting was called to order by RE Joe Vasta at 10:00 AM, who opened the meeting by leading the Pledge of Allegiance. Introductions of Governors/Guests were made.

APPROVAL OF MEETING MINUTES

Michele Cantelmo had distributed the minutes from the September 24, 2011 meeting via email to East Region Governors. Minutes from this meeting will be distributed via email to all East Region Governors. Michele asked for a motion to approve the minutes. The motion was made and passed to accept the September meeting minutes.

READING AND APPROVAL OF TREASURER'S REPORT

Karen Port, ER Treasurer, said the net worth of the East Region is \$32,127.95. The Smith-Barney account balance is \$23,433.86. The Savings account balance is \$5,124.76. The Checking account balance is \$3,812.63. Karen reminded everyone all trophy funds are due. A motion to accept the Treasurer's Report was made. The motion passed.

REGIONAL COMPETITION DIRECTOR'S REPORT

Brian Gallagher reviewed in detail the NCCC Competition Report.

Some of the highlights of the report are:

- Penalties for failure to abide by sanctioning rules. Be certain all paperwork is sent to Brian on time.
- Brian will report points to National for anyone who wants them reported.
- Sanction requests need to be requested on the sanctioned request form.
- Travel points are given once per day. In the event of a multiple event day, you need to delete the travel points which are automatic, and put zero.
- It was stressed to have all event details listed on the flyers. Information pertaining to food availability, bathrooms, etc.
- Region Officers & Governors List was updated.
- Rule Book changes for 2012 did pass.
- Rule Book change requests for 2013 need to be submitted by 4-1-2012.
- Michelin Pilot Sport Cup tires with a wear rating of 80 will be classified in Group 1.
- Workers shall receive travel points.
- Driver's License Number is no longer needed on the tech form.
- Rallye checkers do not have to be at the event.
- An individual can chair and co-chair an event in the same year, obtaining 9 points twice.

Sanction requests for 2012 East Region were reviewed. Dates were added and/or changed. It was mentioned two clubs requesting sanctions on the same day within 150 miles of each other can do so if both clubs agree.
