The meeting was called to order by RE Joe Vasta at 10:00 AM, who opened the meeting by leading the Pledge of Allegiance. Introductions of Governors/Guests were made.

RE OPENING COMMENTS

APPROVAL OF MEETING MINUTES

Michele Cantelmo had distributed the minutes from the September 2013 meeting via email to East Region Governors. Minutes from this meeting will be distributed via email to all East Region Governors. Michele asked for a motion to approve the minutes, moved by Clyde Mooney, seconded by Carl Smith. Motion was passed to accept the September 2013 Meeting Minutes.

READING AND APPROVAL OF TREASURER'S REPORT

Rocky Alleshouse reported the net worth of the East Region is \$33,098.35. The Morgan Stanley account balance is \$23,250.56. The Savings account balance is \$5,763.10. The Checking account balance is \$4084.69. Rocky reviewed the handouts. It was approved at the September meeting to look into a money market account at a bank where more interest can be earned. Rocky is waiting for a return call from Morgan Stanley. Rocky asked for a motion to approve the treasurer's report, moved by Jeff Walker, seconded by Andreaj Balanc. Motion was passed to accept the Treasurer's Report.

REGIONAL COMPETITION DIRECTOR'S REPORT

Highlights of Brian's Report are as follows:

- Reviewed ER Officer & Governors Sheet.
- Reviewed Tips on using the Competition Database.
- Brian stated there is a problem with uploading the excel sheets. He suggested start using the Manual Input.
- Points were reviewed.
- The proposed 2014 rulebook changes were not provided to the webmaster, thus the rulebook changes were removed from the voting ballot and were not voted on. The changes will move forward to 2014.
- Events for 2014 were reviewed for conflicts.
- The ER will have 7 Sanctioned Car Show on May 17th, 2014. Governor's Meeting, Car Show and Awards Banquet will be held on 5/17/14. There is a chairperson.
- Carl Smith was upset as he attended a car show where one hand of cards was dealt for a High and Low Poker Hand. Brian said it is "logical" to have two hands dealt because if you win the High Hand, you have no chance winning at the Low Hand.

This was discussed prior. Joe suggested the outcome of discussions such as this be document in the standing rules. This issue will go to the By Law committee to be looked at.

• There was a lengthy discussion regarding clubs submitting their points according to the National Competition Rule Book. Denny White will assist Free State to report their points from their October show. A copy of the rulebook rules are attached to Brains Competition Report. ER-WEBMASTER REPORT

Joe reviewed the following information:

- Provide Jeff with information about your club for the Spot Light page. He needs text and pictures.
- Vette works training sessions were disappointing. Joe asked if there was a better time for Jeff to do the training. Some Governors mentioned Vette Works is

somewhat cumbersome and is fine for social media. It was determined that the problem ER was having with e-mails was short term.

• ER will default back to using e-mails and doodle for ways of communicating. There will be an investigation of other programs that ER may use to communicate.

Old Business:

- Meeting Site Selection for 2014-2015—Joe spoke about renewing the contract with Holiday Inn for 2014/2015. The price for breakfast went up \$1.00. Everything else remained the same. As there were no alternate sites suggested by the Governors, the assumption is to continue to meet at the Holiday Inn. Hearing no objections, the meetings will be held at the Holiday Inn for the next two years.
- Insurance Coverage—The NCCC Business Manager is currently obtaining two bids for insurance coverage. Joe will let you know as things change. Joe suggested to check out the FAQ's for insurance on the National website. If anyone has insurance questions, they are to go to their Governor. If the governor cannot solve it, the Governor should go to Joe Vasta, and if Joe cannot solve it, he will go the Business Manager. Joe will do his best to answer all questions, and he will provide updates as he gets them. As per Joe, NCCC is saying, NO Waiver, NO insurance. Gaye would like to see a more formal way of relaying information about waivers and NCCC insurance.
- Standing Rule Changes—Bill Sangrey & Andy Alleshouse mentioned there are two actions we need to take. There are wording changes to financial/assessments and sanctions. There were two revisions to the by law changes, that were presented and approved but were not posted on the website. Joe mentioned the bylaws as previously presented are approved and they will be included in the meeting minutes for distribution. There were no objections.
- Nominating Committee & Elections—Bill Sangrey reported the proposed slate of officers, RE Joe Vasta, RMD Andy Alleshouse, RCD Brian Gallagher, Secretary Michele Cantelmo, Treasurer Rocky Alleshouse. All offices were uncontested, none opposed, all nominated officers were elected in lieu of a ballot. In response to Brian Gallagher's question regarding Lt. RCD, the position is appointed by the Executive Board.

New Business:

- The 2014 Budget will be sent out to governors in January for your review prior to the March meeting. There are some line item changes/consolidation. Let Rocky know if you have anything that needs to be added to the 2014 Budget.
- Joe sent around a sign up sheet for "Club Spotlight" articles for Blue Bars. Governors are encouraged to write a 2-3 paragraph about your club, which will be part of the ER quarterly articles in Blue Bars.
- The Trophy Fund Report was reviewed by Andy and Rocky. If you have not paid your trophy fund, please do so as soon as possible. Please mail check to Rocky. Joe thanked Rocky and Andy for preparing the report.
- Joe mentioned there were two additional items for the budget. It was proposed that the ER pick up the two night hotel stay for the National meetings for 2014, 2015 and the first meeting in 2016 for Dave Walter. Motion to cover lodging for Dave Walter moved by Don Emmons and seconded by Clyde Mooney. The ER has 1 member serving on a National level which benefits the Region. Steve Johnson is leaving the Region Board and is not eligible for hotel stays. A

motion was made to reimburse Steve Johnson 2 nights stay for the balance of his 2014 term. None opposed, all approved.

Other Business:

• Dave Walter spoke about expenses for 2015 Convention. Dave will give Rocky an estimate of income and expenses for the warm up events for the 2014 Budget.
