ANNUAL AWARDS PRESENTATION: Bud Benton, 1998 RCD: Bud handed out the overall and individual category awards to their recipients and/or their governors. This year's jackets were a blue denim style with off-white sleeves and off-white lettering. The golf shirts were a navy blue with gold lettering. The patches are not yet completed and will be sent to the winners at a later date. Certificates were also printed and handed out. Bud thanked all the competitors, noting quite a few close races. Cumberland Valley Corvette Club was awarded the overall club championship, and Governor Walter reflected in noting that, if based on individual awards and not total club points, Tri-County Vettes, who had both the men's and woman's overall winners; and who placed first in almost every category; would have won the championship.

SECRETARY'S REPORT: Brian Gallagher. A motion was made, seconded, and approved to accept the secretary's report, sent out by Jeff in lieu of the January meeting. Being no additions or corrections, a motion was made, seconded, and approved to accept. Brian confirmed with all the new governor changes, everyone has received their post cards denoting the meetings. Any address changes must be given to George, and then to Brian.

TREASURER'S REPORT: Karen Port. Karen handed out register reports dated 1/1/99 thru 3/16/99; stating our balance for the period at \$733.12 This is the first time in a while where we are in the black and that is due to a large part of the Funtastic raffle. A motion was made, seconded, and approved to accept the treasurer's report as presented. All in favor.

REGIONAL MEMBERSHIP DIRECTOR'S REPORT: Brian Gallagher for George Fanucci. Our total membership is now at 1,966 members. We (the East Region) are still the largest region in the country, have the largest number of clubs (32), and have THE largest club in the country- **Lancaster County Corvette Club**. The East Region generated **\$33,660.00** to National Council this year. Any club who has not received their membership packets from national should notify George asap.

REGIONAL COMPETITION DIRECTOR'S REPORT: Craig Kahle

The National Awards patches: will be given out at the April National Governors meeting.

Event Results: Must be submitted on time. Sanctions will be suspended if deadlines are not adhered to High Speed Licenses: Currently out of stock.

Competition Rules Discussion: Several items were discussed at the National Meeting regarding oil pan drain plugs, removing emissions equipment on group 2 cars, head modifications, and Hoosier A3503 tires not being legal for group 1 cars. Tread wear and depth will be considered in future tire classifications. Noted is that not all tire sizes are available from all manufacturers in run flats. This will be brought up again in April. A suggestion for annual helmet inspections rather than at each event is being considered. Sectional events are still limited to the 7 event per day rule. After a request by YCCC to have one sanction cover a 2 day event, it was reaffirmed that one sanction is required for each day. Regarding tie breakers at concours shows- if the entrant leaves before the tie breaker is completed, he looses.

Postage increases: \$16.50 or (50) 33 cent stamps for 2 or 3 flyers; \$33 or 100 stamps for 4-6 flyers; and \$49.50 or 150 stamps for 7-9 flyers. NOTE: any additional printed info will be considered another flyer to calculate postage. Multiple flyers should be collated and stuffed in envelopes if possible. Sanction Requests should be complete with chairman names and signatures or signed by the governor and initialed.

Competition Rules Discussion: Several items were discussed at the National Meeting. The tires allowed in the Street Class for C-5's can include NON-EMT tires as long as they are of the type such as GSC or EAGLES- not the G-FORCE or Kuhmo type. In Group ONE, a DOT dual purpose tire will be allowed, however in Group ONE STREET, a DOT-original street tire is required, with a minimum treadwear rating of 110 and a minimum tread depth of 11/32".

RULEBOOK 2000. A lot of changes are being considered. One draft has each club hosting 8 sanctions up from 7, and 4 per day at the same location. Also, class combining is being discussed. For example, in class A & B, and C & D, and MOD A & B. The late model classes E thru H are not being considered for changes. POINTS awarding may change. In speed events, an overall FTD may get 11 points and a group FTD may get 10.

The following are being looked at: Rollbar specs; possible fire suits required in all high speed events; and Snell 95 helmets- which appears a definite change.

REGIONAL COMPETITION DIRECTOR'S REPORT: Craig Kahle/ Brian Gallagher.

A competition report was handed out current as of Oct 9, 1999. CVCC is ranked number one club, followed by CPCC, GBV, LCCC, & TCV. Overall Men's division top spot is JAY GIFT, CVCC, Women's division is SALLY WALTER, CVCC. Trophy fund money is still due from a lot of clubs. Sending one check at year's end is OK. Brian attended the National Governor's Meeting in Louisville in Sept. He reported that the Year 2000 rulebook has been approved with some changes from the current one. One item of most interest is that the proposal of increasing the sanctions to 8 per year was rejected. Sanctions remain at 7 per year per club. Also, no sanctions will be granted during the National Convention in July as was previously considered. All governors should be sending results to the RCD not the VP of Comp; and such results should be gone over for mistakes. Complete NCCC numbers are required, not that one is "pending". Also, times or scores are required. Another note on flyers: the info WILL include the date of the sanction, type of event, region, host club, location city and state

- * Sectional bids have been removed from the 2000 book; as is master grouping for trophies. In place of master grouping, in group I-s; I, II: classes A & B are now class A/B; classes C & D are now class C/D; and class H is confirmed for the C5. In group III, Mod A & Mod B are now Mod A/B; and class H for the C5.
- * A clarification was made regarding the use of the CORSA Pace car exhaust system for the C5 cars. It remains a legal group I-S & group I exhaust system as long as it consists of the original diameter tubing and retains as much functionality as possible as the originally installed factory part. This vote was unanimous.
- It is now REQUIRED of a host club which cancels an event within 24 hrs, or changes location of event, that they post a member at the original location until the close of registration.
- High Speed Licenses: the minimum requirements have been increased from 7 low speed events to 10 within the preceding 18 months. A 3 yr expiration date will be in effect on all licenses, and a minimum of one high speed event will be required within that 3 yr period to renew it. A new supply of licenses will be issued in 2000 to all RCD's, who will receive applications from all governors detailing club members attendance at low speed events for license issuance.
- Tire language for Group I-S was defined. A street tire must have a tread wear rating of greater than 110 and be originally produced with greater than 8/32 inch of tread. Any tire not meeting these requirements will be placed in Group I
- Air cooling of brakes in Groups I-S, I, & II is now allowed, and air foil are allowed now on Group II cars.
- Group III Mod seat belts must be dated within the past 5 yrs.
- Helmets: From now til Jan 1, 2001 the current SNELL or DOT 85 is allowed, after this date, SNELL or DOT 95 will be required.
- POINTS: Group FTD winners will now be awarded 10 points, up from 9, and OVERALL FTD winners will receive 11 points, up from 9 A separate FTD in Group I-S will be added for pre-1984 and 1984 & up.
- Tire sizes; Must be correct for class and axle, ie: no 17x11 rims on front.
- The business manager is checking into the cost of high speed events' insurance to be included in our premiums
- A question Brian asked was if a handicapped driver wanted to enter an autocross, can he? Answer: as long as he is duly licensed, signs all the waivers, and appears to be able to reasonably operate the vehicle, YES he may enter.

- A discussion was held regarding muffler replacements for Group I-S cars? Per the rule book, it must meet three criteria: It must be commercially available; mount under the car; and in the original location. It must meet OEM sizes, and also meet the individual event sound requirements.
- All RCD's were given a complete copy of the revisions for the 2000 rulebook. All Governors, Regional Officers, and National Officers will receive a copy directly mailed to them. All members will receive a coupon in their membership perks packet which must be returned by 5/1/00 for a set of inserts free of charge. After 5/1/00, the inserts or a complete rulebook will be for sale thru the National Distribution Center of NCCC. NOTE: DO NOT THROW AWAY your current book.
- A question was raised whether to judge a two car class in Concours. The answer is YES. The only provision in the rule book for not judging a car is in a one car class.
- A question was raised whether an aluminum DART block was legal in MOD B cars. The answer is YES. Any Corvette or Chevrolet design engine may be used.
- The definition of tire tread depth was discussed. It was noted that Group I-S tires must have a minimum of 2/32" tread in all major grooves. If the major tread goes below this figure, the car shall be placed in Group I
- Early runs for out of town entrants was discussed. It is permissible for clubs to run the first run of the first event, then the second run of the second event, etc; giving the out of town entrants the option of leaving early. NOTE: they will not be allowed to take their runs back to back and prior to the remainder of the competitors.
- Are upper and lower control arm bushings made from polyurethane legal in Group I, 1984 & up? NO. Bushings must be stock rubber. It was noted that GM does not sell the rubber bushings alone, however, they are available if the entire control arm is purchased.
- A quick review of the G-FORCE tires was held. The G-Force KD is a Group I-S tire and the G-Force R1 is a Group I tire.
- All events must have no ties. It should be announced at the drivers meeting how ties will be broken, ie: next fastest run, run off, coin flip, etc.
- Group I-S cars are encouraged to use additional safety equipment such as roll bars, cages, safety harnesses, etc. and remain in Group I-S.

- NOTE: on the calendar due dates: for Non Sanctioned events, the Sanction request due date reflects the 15 days required, not the 70 days that Sanctioned events require, and that the Results due date (15 days after) will be for the signed waivers ONLY, there are no results for Non Sanctioned events.
