- Joe asked for a motion to continue with the 2014 budget plan until the 2015 budget is reviewed at the May meeting. Moved by Gaye Liddick and seconded by Jeff Walker.
- John Cantelmo attended the National meeting in February and here is his report:
- A. 15 Scholarships were given out in 2014.
- B. Reminder when ordering from Ecklers to give them your NCCC number. National will get a kick back of 10% and the region will get a kick back of 5%.
- C. It was voted on and passed to have the NCCC logo over the garage exhibit at NCM. The cost was \$10,000.00.
- D. Presentation was given on Bloomington Gold. The event will be June 25-27 at Indianapolis Speedway. There will be an NCCC Autocross during the event.
- E. NCCC will be having their logo trademarked. The cost \$400.00.
- F. Blue Bars should be available on line by April 2014.
- G. Article 3 Section 1 will change from owners/operators to owners/lease. In this change it would give owners/lease 6 months to replace the car.

APPROVAL OF MEETING MINUTES

Andy asked for a motion to approve the treasurer's report, moved by Jeff Walker, seconded by Clyde Mooney. Motion was passed to accept the Treasurer's Report.

REGIONAL COMPETITION DIRECTOR'S REPORT

John Cantelmo attended the February National meeting. Here is his report:

- Three HPDE proposals for the ER were approved.
- Tech Sheets for the 2015 rulebook will be redone.
- Walter will be developing pre-registration to be done on line. There will be a working model at the next National meeting.
- Clarification of points for people attending the convention was reviewed.
- There is an update tire chart for C3 that has published.
- It was clarified when a group 1 corvette has a wing on it for low speed and the car moves up to group 1 high speed both the wing and bracket must be removed.

• There was a discussion on DNS verses DNF and its effects on a two car class. The discussion will be continued at the next National Meeting, but the general feeling was that a two car class with a DNF should still be considered a two car class. When a two car class has a DNS, that will be considered a one car class.
