#### NATIONAL CORVETTE MUSEUM AMBASSADOR REPORT

- 1. Michele reported on the ER May Car Show. Thirty Five cars had attended to support the East Region. Total money taken in was \$1431.00, minus \$248.00 for expenses; Net Income for the East Region was \$1183.00.
- 2. Michele reported on the 2014 NCCC Convention held in Savannah Georgia. A number of East Region members caravanned together to Savannah. While at the convention East Region members were in training at the registration tables, assisted with the goody bags, parking tags and assisted with the sale of East Region 2015 Convention Shirts. There were a number of activities that were available to take part in. One night was a "Gone with the Wind" theme gathering, where people dressed up in period costume. Dave Walter won the best "Original Male Costume" Award.
- 3. Clyde Mooney reported on the Inaugural Lap at the National Corvette Museum in Bowling Green.

### **New Business:**

- 1. Joe spoke about the NCCC elections. Voting is available from 10-1-14 thru 10-30-14. Go on the National website and click the vote button.
- 2. There are 6 different proposals for the By-Laws, which are on the National website and will be part of the voting ballot.
